

After quite a chilly winter, the warmth of spring and fresh grass can't come soon enough to central New York. For many of us, the changing seasons is one of the most enjoyable aspects of life in our upstate New York communities. Welcome spring!

As we look back at the past couple years, it appears the worst of the COVID pandemic is in our rear-view mirror. Our Oneida County government played a tremendous role in public health assisting at every opportunity – be it staging vaccine pods, providing PPE, conducting contact tracing, hosting testing sites, and countless other health care initiatives. Providing these services and response were at the forefront of the County Board of Legislators and County priorities.

At the onset of the pandemic, the County cut expenses and reduced budgets in anticipation of difficult financial times ahead. Included in these cuts, Oneida County temporarily suspended payments to our local municipalities as stipulated as part of the Oneida Indian Nation (OIN) Partners in Prosperity agreement. Most recently, due to our aggressive approach to representing your interests, all monies for 2020, 2021, and 2022 have been fully restored to the Village of Vernon, Town of Vernon, City of Sherrill, and Town of Verona. Thank you to our local government officials for their assistance and perseverance to work with County officials and reinstate this funding.

Major community projects continue in many of our local municipalities including sewer projects in Villages of Vernon and Oneida Castle, Vernon Center's water project, and City of Sherrill's Main Street initiative. Due to extensive partnerships and grants at the state and federal levels, coupled with multiple agencies that oversee, regulate, and administer these projects, progress is often quite slow and takes several years. Please be assured that our local government officials are doing the best we can to advance and expedite all of these projects in the public's interest.

Our County Board of Legislators again recognizes the burden property taxes place on our residents and for the sixth consecutive year adopted a County budget that includes no increase in property taxes. However, wages for County employees have not kept pace with competitive positions causing for many staff shortages across all County departments. Addressing this dilemma will be a major focus in the coming months.

Several very positive economic development initiatives continue to evolve in Oneida County. Most recently, construction at the downtown Nexus Center has resumed, the Wynn Hospital of the Mohawk Valley Health System continues its development and plans for the hospital parking garage are on track, and the CREE / Wolfspeed Marcy Nano Center is gearing up for production with more development in the works. Additionally, several exciting high-tech projects, such as SkyDome, continue to develop at Griffiss. All of these exciting projects strengthen our collective communities and support our region's economic development.

As your County representative, it is again been my pleasure to serve you and work with our team of elected village, town, and city government officials. Our dedicated and competent supervisors, mayors, and board officials have been a tremendous asset to our collective communities. Thank you for your "vote of confidence".

Whether you're receiving the STAR credit or exemption, the benefit can change each year due to a variety of factors, including school tax rates, changes in property values in your community, and local assessment practices.

As a result, the STAR credit benefit may not always increase, and when it does increase, it may do so by 2% or less.

However, the STAR exemption benefit can never increase, even when the STAR credit benefit does increase. The STAR exemption benefit will never be higher than the STAR credit benefit.

How much will I save?

To determine how much you could save by switching to the STAR credit:

- 1. Find the amount of your STAR savings on your most recent school tax bill.
- 2. Multiply the STAR savings by 1.02 to see how high your STAR credit benefit may be this year if you switch to the credit.

All trees will be planted during the proper season to optimize survival and growth. Each tree that is planted will include a ground plaque commemorating the person/persons for that tree.

TOWN OF VERNON ASSESSOR NEWS

March 1 is the deadline for filing certain property tax exemption applications with the Assessor's office. Below is a list of the most common property exemptions:

Basic STAR – Renews automatically- available for primary residence to all homeowners with income less than \$500,000.

Enhanced STAR – Renews automatically – available to homeowners 65 or older with income less than \$92,000.

Please note that to receive these exemptions you must apply for the initial year, contact the assessor's office for information or visit https://www.tax.ny.gov/pit/property/star/default.htm.

Veteran Exemption – Renews Automatically (if you receive the disabled Veteran's exemption and your percentage of disability changes you must bring your paperwork to the assessor's office so your exemption can be updated).

Senior Citizen's STAR Exemption — Based on an Executive Order by the Governer of New York State issued December 26, 2021, **Seniors who received the Senior Tax Exemption for 2021 do not need to renew that exemption for 2022.** This is the same situation as we had for the 2021 assessment year.

To apply for a **new** Senior Exemption, you can visit the Assessor's office located in the Vernon Town Hall (315-829-2587). The Vernon Assessor's hours are Monday thru Thursday 9am-2pm.

Many people who are currently receiving the STAR Exemption (both Basic and Enhanced), might want to think about changing to the STAR Credit. Let me explain the difference: The exemption benefit is deducted from your school tax bill prior to you receiving the bill in the mail, the credit is a check that is sent to you from the state (received prior to the school tax bill being due) for the amount of your STAR savings.

What is the benefit of changing to the credit? See the info below from the State web site:

Why switch to the STAR credit from the STAR exemption

If you currently receive your STAR benefit as a reduction on your school tax bill (the STAR exemption), you may receive a greater benefit if you switch to the STAR credit to receive a check instead.

The value of the STAR credit savings may increase by as much as 2% each year, but the value of the STAR exemption savings cannot increase. The STAR exemption savings can never be higher than the amount of the final STAR credit.

The STAR credit benefit can continue to grow

By switching to the STAR credit, your benefit could grow by as much as 2% each year, and it can never be lower than the STAR exemption benefit.

For example, if your STAR exemption benefit was \$800 on your 2020-2021 school tax bill, that's the most you can receive in any future years, **unless** you switch to the STAR credit.

If you switch to the STAR credit, your benefit can grow by as much as 2% each year.

- In the first year, that could mean up to \$816—an extra \$16 in savings.
- Five years later, the STAR credit benefit could reach as high as \$900 due to the power of compounding,

Codes Office News & Updates



If possible, please call ahead and schedule a time to meet with one of our code enforcement officers. They are not always in the office during business hours due to fire inspections, building inspections, other appointments, etc. Our office hours are Monday thru Friday 9:00 am – 1:00 pm (315) 829-2434

All of the following require building permits through our office:

- New homes including double wides
- · Garages, Sheds and Carports
- New septic systems or changes to existing septic systems
- Remodeling interior or exterior, additions
- Decks, porches (including enclosed)
- Above ground, in ground pools and hot tubs/Jacuzzis
- Fences, ramps
- Chimneys, wood stoves, or outdoor wood/gas burning devices

Address Identification

Minutes Matter!!

It is difficult for Emergency Responders to locate you when address numbers are not properly posted on homes or businesses. This can increase the response time and possibly effect the outcome of a situation.

Below is a list to help with the placing of address numbers:

- Address Identification should be legible and placed as to be visible from the road.
- · Numbers should contrast from their background.
- Numbers should be Arabic numbers or Alphabetic letters
- Each character should not be less than 4 in. height by ½ inch width.
- If house/building cannot be seen from road a pole, monument or other means should be used to place address closer to the road.
- ••• Reflective numbers can be purchased from some local Fire Departments and most stores •••

MAKE YOUR HOME FIRE SAFE

- Smoke detectors save lives. Install a smoke detector outside each sleeping area and on each additional level of your home.
 - Use the test button to check each smoke detector once a month.
- Have a working fire extinguisher in the kitchen. Get training from the fire department in how to use it. Also include in the kit written instructions on how to turn off utilities at your house.
 - Conduct periodic fire drills, so everyone remembers what to do when there is a fire.

PLAN YOUR ESCAPE ROUTES

- Determine at least two ways to escape from every room of your home. If you must use an escape ladder, be sure everyone knows how to use it.
 - Select a location outside your home where everyone would meet after escaping.
 - Practice your escape plan at least twice a year. Once you are out, stay out!

ESCAPE SAFELY

- If you see smoke in your first escape route, use your second way out.
- If you must exit through smoke, crawl low under the smoke to escape.
- If you are escaping through a closed door, feel the door before opening it. If it is hot, use your second way out.
- If smoke, heat, or flames block your exit routes, stay in the room with the door closed. Signal for help using a bright-colored cloth at the widow.
 - If you have access to a phone, call the fire department and tell them where you are.

Another major consideration is the center of the road. The center must be cleared of snow, which necessitates the front left part of the plow crossing the center line and into oncoming traffic. When you encounter an oncoming snowplow you should slow down and move over as far as is practical to give the snowplow room to clear the center of the roadway.

Please note per New York State VTL Article 1219 prohibits plowing, shoveling or blowing snow into or across the roadway. This action causes a dangerous winter hazard resulting in accidents and severe vehicle damage.

The final topic involving snowplowing is mailboxes and other roadside objects; such as parked vehicles. These can add to the difficulty of a snowplow operator's job. Snowplow drivers do their best to avoid these obstacles, regrettably damage to a mailbox can occur simply due to the weight of the snow or as the result of an oncoming vehicle not giving the snowplow enough room, requiring the plow operator to move closer to the side of road.

In closing of this topic, I urge all motorists to remember there is a high level of demand during the winter season as our dedicated employees continue to try and keep our roads as safe as possible. We need you to do your part and be careful and alert but mostly SLOW DOWN!

ANNUAL EVENTS

BRUSH PICK UP

- First full week of May is brush and weeds pick up. Once you have placed all of your material roadside call the highway garage (315)829-2742 and give your address. This will make scheduling of pickup more efficient for all. The Village of Vernon, City of Sherrill and Village of Oneida Castle have their own designated brush removal systems.
- We do have a site available at the highway garage at 4322 Churton Road for town residents to bring small limbs, leaves and grass clippings during warm weather.
- The Town does NOT accept Commercial green waste. These contractors are paid by the homeowner to remove their brush; therefore, they have to dispose at facilities that except it not at the Town. The Town's green waste site is limited in size and it can't handle the excessive amount that commercial green waste brings.

WHITE GOODS DAY

At this time the Town has decided to suspend this service due to lack of interest.

ONEIDA CASTLE NEWS

The Oneida Castle Village Board has been working diligently on the sewer project throughout the winter. The first round of bids all came in over our budget, so they have been rebid and will be opened the first week in March. The Board is still looking into supplemental funding to offset the cost of delays due to COVID and the rising price of materials.

The entire sewer system plans were redrawn to further reduce the cost of the project. The lines will be laid higher then originally planned which will remove the need for one pumping station and some forced mains which were very expensive.

The Village has also applied for another Clean Water Grant due to being denied the first application. The Village will need another grant or more funding to continue.

In other news, residents may notice that the trees in our park have all been tagged. All 125 trees are now marked through a grant by the Soil and Conservation Dept. These tags will give the location of each tree on a GPS system and can be identified according to condition for future trimming, removal, etc.

In final news, the Village Board has purchased a new sidewalk plow/snow blower in order to better keep our sidewalks clean. This new Kubota will be a 4 wheel drive to replace the older 2 wheel drive tractor which was unable to do an adequate job.

The Green Thumb Garden Club of Oneida Castle is always looking for new members and would welcome any organizations or individuals who would be willing to weed the Veterans Memorial park and other garden areas. Arrangements can be made for those needing volunteer credit for school as well. If interested, please contact Sharon Myers at 315 363-8624. The Garden Club meets the last Thursday of each month at 6:00pm in the village hall. All are welcome.

SNOWPLOW DRIVERS ASK FOR YOUR CONSIDERATION

During the snowplowing season, highway crews ask for the cooperation and understanding from motorists. By the nature of the task, snowplowing operations take place during poor visibility and drivers tend to follow plows too closely. The process of clearing the roads of snow often require plows to backup, usually at intersections, where they must turn the corner, dump the load of snow and back up before continuing. All too often vehicles fill the space where the plow must back into. Please remember to give the snowplow plenty of space, especially at intersections.








I would like to start by thanking all of the residents who voted to re-elect me as Town Supervisor. I take pride in serving my community and am happy to say, with good partnership of the Town Board, the Town has successfully passed budgets without any tax increase during my entire time as Supervisor.

I would like to commend the Highway Superintendent Tim Murphy and the entire Town of Vernon Highway Department on doing an amazing job of keeping our roads safe and in excellent condition.

I would like to give an update on the Vernon Center Water Project. The Town Board and myself in coordination with Delta Engineers, Architects and Surveyors we have been working diligently applying for every grant possible to secure funding.
