# May 12, 2025

The regular meeting of the Town Board of Vernon was held at the Town Office Building on the above date with the following persons present: Randy Watson, Supervisor; Gene Bennati, Steve Adamkowski, John Peters, Myron Thurston, Council members; Keith Scheibel, County Legislator; Cindy as a representative from Assemblyman Brian Millers office. Also present: 42 community members.

Following the Pledge of Allegiance, there was a moment of silence. The meeting was called to order by Supervisor Watson at 7:00 p.m.

Supervisor Watson asked the council members if there were any additions or corrections to the minutes of the April 14, 2025, meeting. There being none, a motion to accept the minutes as written was made by Thurston, seconded by Adamkowski. No discussion. Ayes 5. Nays 0. Motion carried.

#### **BUSINESS**:

Chris from Delta Engineer spoke on the Vernon Center Water District Project. The project has been put out to bid. Currently 19 companies have requested the plans. The bids are due by May 30, 2025. Bid packets include 6.2 miles of 8-inch water main directionally drilled, 39 hydrants, water tank, and booster pump. There are 3 contracts to this bid which include the booster pump, water tank and the water distribution system. This is a buy America project. Meaning that the materials are produced in the United States.

- Irrigation
- Use of black plastic/mulch

Fred Polsinelli responded to the concerns on behalf of Nonna Farms

- Medical cannabis company
- Proposal/plan/agreement to have a highly secure outdoor cultivation operation
- Smell occurs during the harvest season for approximately 3 weeks in the immediate area of the farm
- There will be 24-hour surveillance security
- No pesticides will be used
- The entire site is 52 acres. 40 acres of plants
- Office of Cannabis Management regulates
- Fully bonded
- 4 wells have been drilled

Town Attorney, Vincent Rossi advised of the state requirements for this operation

- Site plans provided to the State of New York
- Operation Plan
- Sanitation requirements
- Tier and canopy requirements for fences
- Product must be tagged and traced when it leaves the facility
- Security requirements

• New York State classifies cannabis as an agriculture crop

Assessor's software program with Systems Development Group (SDG) has been sold to Schneider Geospatial. Schneider Geospatial has an increase in costs of \$60 per year and is converting all clients to a fiscal year. Duane Munger assessor Chairman signed new agreement.
